 - A request was sent to the province to change the scope from Wastewater Membrane Bioreactor Container Project to Lagoon Expansion.
 - The proposed new process is to expand the lagoon system by adding capacity to the facultative cell and building a second storage cell. The expanded capacity will allow additional treatment/holding time. With the lagoon system expansion, the lagoon will change to an annual discharge in the fall from the current bi-annual discharge (spring/fall) which will improve the quality of the release water. The expansion will be sized to accommodate the anticipated 2040 design population.
- 9.3 Playgrounds and Emergency Call Centre Operations
 - Playgrounds within the region were opened to the public June 1, 2020 with the provisions that the public are responsible for adhering to the AHS guidelines in preventing the spread of the COVID-19 virus.
