A By-Law being Number 530 of the Town of Wembley, in the Province of Alberta, authorizing Council to enter into an agreement with the County of Grande Prairie No. 1 to form an area recreation board.

WHEREAS the Council of the Town of Wembley deems it necessary to be in the best interest of the ratepayers to enter into an agreement with the County of Grande Prairie No.1 to provide a recreation program, and

THEREFORE, in conformity with Section 113 of the Municipal Government Act, Revised Statutes of Alberta 1980, Chapter M-26, the Council of the Town of Wembley enacts as follows:

THAT the Council of the Town of Wembley be authorized to enter into an agreement with the County of Grande Prairie No. 1 to form an area recreation board known as the "Wembley and District Recreation Board" to administer and promote recreation for the Town and district jointly with the County of Grande Prairie No. 1 in an area legally defined as follows:

All that area within the said County commencing at the intersection of the Beaverlodge River and Wapiti River in the northwest corner of the South East Quartion of Section Four (4), Township Seventy (70), Range Nine (9) West of the Sixth Meridian; thence north and following the Beaverlodge River to the junction of the the Beaverlodge River with Sprace Creek; thence following Spruce Creek to the northwest corner of the North West Quarter of Section Twenty One (21) Township Seventy One (71) Range Nine (9) West of the Sixth Meridian; thence east to the southwest corner of the South West Quarter of Section Twenty Seven (27); Township Seventy One (71), Range Nine (9) West of the Sixth Meridian; thence north to the northwest corner of the North West Quarter of Section Twenty Seven (27), Township Seventy Two (72), Range Nine (9), West of the Sixth Meridian; thence east to the south west corner of the South West Quarter of Section Thirty One, (31), Township Seventy Two (72), Range Eight (8) West of the Sixth Meridian; thence north to the northwest corner of the North West Quarter of Section Thirty One (31) Township Seventy Two (72) Range Eight (8) West of the Sixth Meridian; thence east to the junction of Bear Lake in the North East Quarter of Section Thirty One (31), Township Seventy Two (72) Range Seven (7) West of the Sixth Meridian; thence following the north shore of Bear Lake to the northwest corner of the North West Quarter of Section Nineteen (19) Township Seventy Two (72) Range Six (6) West of the Sixth Meridian; thence south to the northwest corner of the North West Quarter of Section Thirty One (31) Township Seventy One (71) Range Six (6) West of the Sixth Meridian; thence east to the northwest corner of the North West Quarter of Section Thirty Six (36) in the said Township and Range; thence south to the northeast corner of the South East Quarter of Section Eleven (11) Township Seventy One (71) Range Six (6) West of the Sixth Meridian; thence east to the northeast corner of the South East Quarter of Section Twelve (12) in the said Township and Range; thence south to the southeast corner of the South East Quarter of Section One (1) Township Seventy One (71) Range Six (6) West of the Sixth Meridian; thence east to the northeast corner of the North East Quarter of Section Thirty Six (36) Township Seventy (70) Range Six (6) West of the Sixth Meridian; thence south to Six (6) West of the Sixth Meridian; thence south to the northeast corner of the North East Quarter of Section Twenty Four (24) Township Seventy (70) Range Six (6) West of the Sixth Meridian to the junction of the said quarter section with the Wapiti River; thence west along

the Wapiti River to the point of commencement, plus all that area within the legal boundaries of the Town of Wembley.
